

# FMCF FY 2026 Release Notes

#### **November 14, 2025**

Treasury's Bureau of the Fiscal Service (Fiscal Service) updated the Financial Management Capability Framework (FMCF) to align with recently approved changes to the Federal Financial Management (FFM) Business Standards, feedback from Other Lines of Business (LoB), and feedback received from federal agencies and industry during the public comment period.

FMCF components not impacted by changes are still included in the update and were refreshed for the FMCF FY 2026 version.

A summary of the changes by topical area is included below along with references to impacted FMCF components.

#### • Expanded Core FS Pre-Built Business Information Exchanges (BIEs)

Added or updated BIE specifications for the following systems and associated content in the FFM Functions and Activities, FFM Business Use Cases, FFM Business Capabilities, and FFM Business Data Elements:

- GSA GO.gov (ETSNext)
- Treasury Collections Information Repository (CIR)
- Treasury Do Not Pay (DNP) Portal
- Treasury Shared Accounting Module (SAM)
- Treasury Invoice Processing Platform (IPP)
- Treasury Payment Automation Manager (PAM) and Secure Payment System (SPS).

### • Expanded Core FS Pre-Built Business Reports

Added or updated business reports for the following FFM Functions or Activities and associated content in the FFM Functions and Activities, FFM Business Use Cases, FFM Business Capabilities, and FFM Business Data Elements:

- Payment Reporting
- Receivable Management
- Delinquent Debt Management
- Financial Reconciliation
- Financial Statement Preparation.

# • Incorporated changes to the Statement of Federal Financial Accounting Standard (SFFAS) 54, Leases and its related SFFASs

The following FMCF components were updated to reflect these SFFAS changes:

- FFM Business Use Cases
- Core FS Pre-Built Business Information Exchanges (BIEs).



#### • Aligned with FM Authoritative and Other Reference changes

FMCF components integrate requirements prescribed by authoritative and other documents issued by the President, OMB, Fiscal Service, the Federal Accounting Standards Advisory Board (FASAB), and other standards setting bodies. The following FMCF components were updated to align with authoritative and other reference changes:

- FFM Functions and Activities
- FFM Business Use Cases
- FFM Business Capabilities (FFMSRs)
- FFM Business Data Elements
- Core FS Pre-Built Business Information Exchanges (BIEs)
- Core FS Pre-Built Business Reports
- FM Provider Service Measures.

Added FM Solution/Service Evaluation Criteria indicator to address technology supply chain assurance.
